

Dear America,

The WHO, CDC, NIH, and other organizations are run by one person. Too often that one person is controlled by a hidden agenda. It is not enough to replace them. Compromised people get in control eventually. So, what can we do?

The *Magna Carta*, *Charter of Liberties*, our *Declaration of Independence* and our *Constitution* were all drafted by a greater body of involved consent and not just by one person. Even the *French Tennis Court Oath* and the *Iroquois Five Nation Confederacy* were created by many participants. Great things happen from many. Let's recreate this model to advance the best ideas? Why not create an American Health and Disease Council, but with no single executive in control? Here's how it works:

### **PARTNER MEMBERS**

Create a website where all health professionals, infectious disease experts, medical PhD's, biologists, naturopaths, homeopaths, geneticists and so on can register first as Partner Members to be selected as Practitioner Members. These Partner Members upload their credentials and licensure if they have any, and they are allowed to advance and submit research for peer review.

### **PRACTITIONER GROUP**

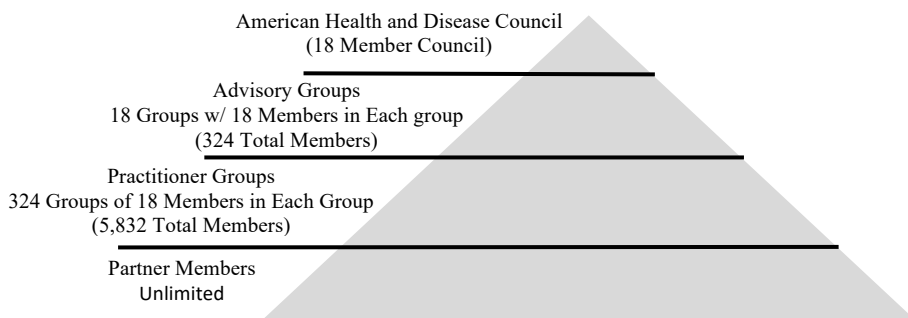
Practitioners are selected from the pool of Partner Members by lottery as positions become filled. Partner Members can then move into Practitioner Groups of 18 where we organize these Practitioner Groups locally as much as possible. The goal is to fill 324 Practitioner Groups with 18 members in each group, which totals 5,832 members. Enrollment is always open and membership is unlimited below the Practitioner Level, however each member, if put in a Practitioner Group, must be a Citizen of the United States. We can ask for certain specialties, education, experience etc. from each state for informed representation.

### **ADVISORY GROUPS**

One representative from each Practitioner Group is selected by super majority (14 of 18). Unanimous consent is preferred. These representatives are placed into Advisory Groups as locally as possible. Advisory Groups advance papers and research findings by super majority. They send these to their representatives on the Advisory Council, which are elected in the same fashion, one representative from each advisory group to serve on the American Health and Disease Council.

### **AMERICAN HEALTH AND DISEASE COUNCIL**

The American Health and Disease Council then advises the Executive and the Legislative branches on health and disease policy, and they replace the FDA, CDC, NIH and other centrally controlled organizations. It's the most decentralized body of involved consent ever created in American history.



Immediately after all are assembled, in consequence of the first election, members shall be divided into three classes. The seats of the first class shall be vacated at the expiration of the second year. Of the second class at the expiration of the third year. And of the third class at the expiration of the fourth year, so that one third may be chosen every second year thereafter. Class assignment is given upon being advanced to a Practitioner Group. If advanced, the member begins a two year term for the class being replaced and then their class position is replaced to complete the term.

When we have 5,832 members from across the country with education, training and expertise in the areas needed, the entire system is activated. Expertise to be confirmed in Practitioner Groups before they meet. Partner Members are advanced to a Practitioner Group with a super majority of 14 votes (not including their own vote). This happens after they meet for the first time. In order to secure adequate representation for each state, we will keep half of the membership (2,916 positions) proportioned out for the states respectively, with each state getting 58 members in the Advisory Groups. The rest will be randomly selected by the blockchain code from Partner Members to fill 5,832 positions once approved.

We are fighting all the unelected and appointed positions that are compromised and compliant to a hidden agenda. We have a chance to create a fresh start and build something without compromised people and in multiple departments, divisions, and yes this could be a model for other countries and the World. We now have a semblance of what needs to be done. Increase more voice or die.

Imagine not being forced to trust one person who is easily compromised by hidden interests and corporate profiteering, but instead we get ideas and the informed consent of many. Americans love to hear as many voices as possible. From such a process we make great decisions. But not all men and women are like this. Decentralize now, or will succumb to darker intentions. Get power back to the people. It's the only way we can advance American greatness.
